Working groups

The afternoon session will consist of breakout sessions which will deliver concrete recommendations for multilateral and bilateral CT efforts in the Horn of Africa. Each group will be responsible for delivering suggestions to mitigate the push factors of radicalisation and tailored to different actors (i.e. EU/GCTF/IGAD and bilateral). Each will be co-moderated by the NL MFA and an expert.

General question: how can the international community mitigate particular drivers of radicalisation and which organisation should focus on what?

- 2. Political drivers: Corruption / power abuse / repression the example of Kenya (co-moderators Jean-Christophe Hoste / Agnes Koppelman NL MFA)
- 3. Social drivers: Marginalisation/ cross-border tribalism (co-moderators Eelco Kessels, / Janneke van Hemmen NL MFA)

Conclusion and recommendations session

In the conclusion and recommendations session, one of the co-moderators of each session will provide five-minute conclusions from the break-out sessions, which the moderator, Cristina Barrios, will translate into concrete recommendations for improvements of the multilateral response to radicalisation in the Horn of Africa.

Desired outcome

Policy Brief with clear context-specific recommendations for future multilateral CT engagement to mitigate specific push-factors of radicalisation in Horn of Africa, taking into account the broader discussions on the link between CVE and development, as well as the GCTF 'life cycle of radicalisation' initiative.
