Security Sector Reform (SSR) in the Middle East and North Africa presents unique challenges: the authority of states is not always fully established, open conflict is widespread, resource constraints are severe, and non-state armed actors, as well as armed civilians complicate the picture. The Joint Communication of the European Commission and the High Representative of July 2016 recognises these difficulties and proposes a more comprehensive and adaptable approach to SSR in environments that present particular challenges, such as in the Southern neighbourhood.

The seminar seeks to contribute to this by bringing together practitioners from the field and EU officials, in order to provide elements of discussion to a more tailored approach to SSR in the region.
